No license is created by the adoption of this division authorizing any other uses. All the provisions of this division are and shall be subject to such regulations which the governing body of the City of Ellijay may deem advisable for the proper control and regulation of the sale and consumption of malt beverages and wine. This division and such regulations may be from time to time amended. All such provisions of the regulations, as may be then or thereafter in force, and subsequent ordinances. All such licenses shall be nontransferable and shall convey to the licensee no property right, but only a privilege, which may be revoked by this body.
